There will be no affiliate or white label use for this campaign and no other content providers or brands will be used on this phone number without a new submission. The maximum number of messages sent to any subscriber will be 20/week.

All messages sent on this campaign are strictly on an opt-in basis and no "premium" messaging is allowed. Users who have opted in can opt out by texting STOP, QUIT, CANCEL, END, UNSUBSCRIBE, REVOKE or OPTOUT at any time. A message confirming the opt-out will be the last message sent by TextPower to that number until it opts in again by texting "SECIN" to 843-355-6187.
